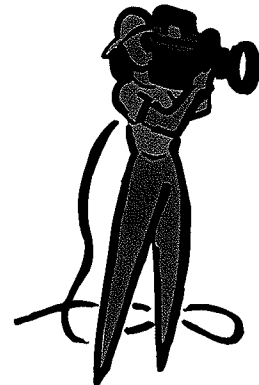
GENERAL LIABILITY COVERAGE

We have an excellent liability program available. This is a \$1,000,000 liability policy with a \$350 minimum premium, \$10,000 medical payment limits and \$300,000 fire damage limits. Certificates can be issued to your clients within 24 hours.

COMPUTERS AND EDITING EQUIPMENT

We can insure computers (desktops), editing equipment and related items that remain in the office at a substantially lower rate. ** These items are at a much lower risk of loss and our rate will reflect this. Not only will the cost be substantially lower, the coverage has been designed specifically for this type of equipment, underwritten by a leader in business insurance protection for electronics and computers. Unfortunately, you are unable to update the equipment on line at this time. Minimum premium is \$300.
